The meeting was opened by a short address of welcome by Dr. Frederick B. Noyes after which the program for the three days was outlined by Dr. Allan G. Brodie. The mornings were consumed in study and practice of the following technical procedures: Arch Forming directed by Dr. Gromme, Soldering and Placing of Staples directed by Dr. Meyer, and Band Forming directed by Dr. Brodie. For this work the attending members formed three groups which rotated daily spending the entire morning in bench performance

of the procedures under the observation and guidance of the men in charge of the respective groups.

The afternoon sessions were devoted to a resume of fundamental principles and their practical relation to the theoretical treatment of Class II Division I cases. The field was splendidly reviewed by Dr. Brodie in three three-hour lectures: "The Anatomy, Growth and Development of the Face," "The Forces of Occlusion and the Part Each Plays in the Normal Denture," and "Treatment of Class II Division Cases with the Edgewise Arch."

After disposing of the business pertinent to this meeting, letters were read relative to the International Orthodontic Congress to be held in London, England, in July of this year. It was the unanimous decision of the society that if time could not be arranged to adequately present the paper and clinic to be given by the Angle Society on the New Mechanism, to withdraw the offer. The evening meeting was concluded by a "Review of the Principle and Accessory Factors in the Development of Bone," presented by Dr. Frederick Noyes.

The next meeting will be held in Chicago in September or October, the date to be decided later.
