Prize Essay Contest

The Research Committee of the American Association of Orthodontists has been empowered by the Board of Directors to conduct a prize essay contest. The prize has been set at \$200.00, and will be offered annually until further notice. The terms of the competition are as follows:

Eligibility

Any student enrolled in a recognized university, or any person who has completed his or her formal education in orthodontia not more than three years prior to January 1, 1944, is eligible to compete for the prize.

Essay

The essay must represent a piece of original research having a direct bearing on the field of orthodontia. It may relate either to a biological or clinical problem and may represent material that has been offered in partial fulfillment of the requirements of a graduate or postgraduate degree, or any graduate, postgraduate or undergraduate contest. Papers previously submitted and now published or in press will be accepted for the present contest. All essays must be in the hands of the committee by February 1, 1944. If no essay is deemed worthy by the committee, the prize will be withheld.

Award

The prize-winning essay will be accorded a place on the scientific program of the annual meeting of the Association, at which time the prize will be awarded. The Association will retain publication rights on the first three choices.
