## Announcements

### Prize Essay Contest

American Association of Orthodontists

THE RESEARCH COMMITTEE of the American Association of Orthodontists is empowered by the Board of Directors to conduct a prize essay contest. The prize has been set at \$200.00 and will be offered annually until further notice. The terms of the competition are as follows:

#### *Eligibility*

Any student enrolled in a recognized university, or any person who has completed his or her formal education in orthodontia not more than two years prior to January 1, 1945, is eligible to compete for the prize.

#### *Essay*

The essay must represent a piece of original research having a direct bearing on the field of orthodontia. It may relate either to a biological or clinical problem and may represent material that has been offered in partial fulfillment of the requirements of a graduate or postgraduate degree, or any graduate, postgraduate or undergraduate contest. No papers previously submitted for publication or in press will be accepted. All essays must be in the hands of the committee not later than two months prior to the annual meeting of the Association. Consult periodic literature for this date. If no essay is deemed worthy by the committee the prize will be withheld.

#### *Award*

The prize-winning essay will be accorded a place on the scientific program of the annual meeting of the Association, at which time the prize will be awarded. The Association will retain publication rights of the first three choices.
