

## Reports of Meetings

### **The Northern California Group of the Edward H. Angle Society of Orthodontia**

The Northern California Component Group held its first meeting on September 1, 1932. The principal business was the election of officers and acceptance of a program for the following four months. George W. Hahn was elected chairman and Herbert R. Foster, Secretary-Treasurer.

The members voted to devote the balance of the year to the study of the subject of "Diet and Nutrition" and to engage Miss Adelle Davis, Consulting Nutritionist, who is a graduate of the University of California and has continued her studies at Columbia, to deliver a series of lectures.

The first of these lectures was delivered on September 14th on the subject of Vitamin A. The entire time was given to a consideration of its relation to growth and development of the teeth and to the health of the body as a whole; its bearing on experiments of Wolbach and Howe; plant synthesis of carotene; the action of the liver on Vitamin A; and the sources, amount needed and storage of this important Vitamin.

The course will cover a critical survey of the dental research completed at the present time by Doctors Boyd, Drain, Bunting, Hess, Eddy, Klein, McCollum, Hanke, the Toveruds, the Mellanbys, Jones, Hawkins and others.

Some of the other lectures that will be given are on Vitamins B, C, D, E and G; Calcium and Phosphorus Metabolism; Acid and Alkaline Balance; and Analyses of diets of races that have been relatively free from malocclusion and dental diseases.

Perhaps every patient who needs orthodontic treatment has or has had a dietary problem. If the best orthodontic service is to be given more must be learned about foods and their reaction on growth and development and passed on to the patient. This course of lectures should do much to stimulate a deeper consideration of the subject of nutrition and thereby help directly to give better orthodontic service.
