Obituary

Genette Weaverling Harbour

Frances Genette Weaverling was born on December 15, 1865. Her parents, Peter and Sarah Weaverling, were pioneers of Pennsylvania, but her early childhood was spent in Nebraska, where she later taught school. She was active in musical circles; among her musical friends were Dr. N. M. Buck and his wife Katherine, and Senator Benjamin A. Harbour, to whom she was married a year after her graduation from the University of Southern California.

Miss Weaverling and Mrs. Buck studied dentistry together and in 1903 they were graduated from the Dental Department of the University of Southern California. After a few years of general practice in Los Angeles, Dr. Harbour decided to devote her energies to orthodontia; in 1912 she was graduated from the Edward H. Angle School of Orthodontia, then located at New London, Connecticut. Returning to Los Angeles, Dr. Harbour established her practice, demonstrating her unusual skill in the successful treatment of malocclusion in children.

Dr. Harbour was a member of the following organizations: Edward H. Angle Society of Orthodontia, Southern California Dental Association, American Dental Association, Los Angeles County Dental Society, Women's Athletic Club, Women's Club of Southern California, Alpha Upsilon Pi and Omicron Kappa Upsilon.

Their mutual interests and the sympathies of an earlier friendship bound Dr. Harbour and Dr. Kate D. Buck closely together throughout their professional lives, and after the death of her husband Dr. Harbour made her home with Dr. Buck until she died on February 3, 1936.

The qualifications of an ideal orthodontist seem to have been epitomized in Dr. Harbour, who will live in our memory as an inspirational guide and a crusader in behalf of the best in character and idealism. Never disagreeably aggressive, yet possessing a convincing frankness of expression, Dr. Harbour had the courage of her convictions. Her gentleness of manner and speech and her assuring encouragement so established her in the affections of those privileged to know her that her memory continues as a blessing and a benediction.
