The 30th Biennial Meeting of the Edward H. Angle Society of Orthodontists was held at the Grove Park Inn, Asheville, North Carolina, October 23-27, 1993. The meeting was presided over by President Theodore Adler, White Plains, New York, and hosted by the Eastern Component of the Angle Society. Lysle Johnston, Jr., of Ann Arbor, Michigan, delivered the Angle Memorial Lecture. Everett Shapiro of Brookline, Massachusetts and Coenraad Moorrees of Lexington, Massachusetts were honored for their outstanding contributions to orthodontics and the Angle Society.

Drs. Sheldon and Leena Peck received the Edward H. Angle Research Award for their article "The Gingival Smile Line" (Angle Orthod 1992; 62:91-100.)

ment Chairman Arthur Babineau effectively enabled the 127 Angle members in attendance to fully enjoy the charm of the Grove Park Inn and the beauty of the surrounding area.
