We believe that the time has come when orthodontists will support a publication that is financially independent of any commercial organization. To make such a project successful, however, requires cooperation. The editors are such that full value for every subscription is more than assured by the calibre of the articles that appear in each issue. Will not each reader assist the Business Manager by soliciting new subscribers? If you like this Journal pass the good word along. If you do not
