Mail Order Orthodontists.—Charles R. Baker

This presentation is in the nature of a report study conducted by a committee of the Chicago Association of Orthodontists of which Dr. Baker was Chairman inquiring into the laboratory construction of orthodontic appliances and supervision of treatment. The study of this committee revealed that advice was given without adequate history and diagnostic data such as X-rays and oral examination considered essential in the planning of orthodontic management. It is a rare exception that the laboratory demands X-rays before giving advice with respect to treatment or construction of appliances. Many samples of appliances constructed and advice offered by the laboratory were exhibited, and evidence through data accumulated by Dr. Baker and his committee indicated that this practice is neither to the best interest of the patient or the profession.
